A shift in Safety Levels must be able to be maintained for a substantial amount of time to minimize the need for on-going changes and to set expectations for all community members. Guidelines for All Safety Levels

- Please check Sonoran University's Infectious Illness FAQs frequently for updates.
- Individuals should stay at home when symptomatic.

Individuals will self-isolate for 5 days after testing positive for an infectious illness.

- A negative test is required for return to campus after confirmed COVID-19 infection or exposure.
- Asymptomatic individuals will wear an N95 mask on campus for 5 days after exposure to a confirmed communicable illness.
- Regularly clean high-touch surfaces (e.g., door handles, counters, light switches, remote controls, restroom surfaces).
- Wash your hands often and use hand sanitizer.
- Do not touch your face or mask.
- Wear a face covering in accordance with Sonoran University Campus Masking Protocols.
- High-risk individuals should take extra precautions at all safety levels.
